: The product obtained from cod liver fatty oil with a high content of unsaturated fatty acids, average: 99% fat, 0.85% cholesterol, 0.026% vitamin A (corresponding to 85,000 IU per 100 g), 0.0002% vitamin D (equivalent to 8500 IU per 100 g), the fatty acid composition. 16:0 palmitic acid 7.0-14.0%, 16:1 palmitoleic acid from 4.5 to 11.5%; 18:0 stearic acid 1.0-4.0%; 18:1 oleic acid from 12.0 to 21.0 %; 18:2 linoleic acid 0.5-3.0%; 18:3 linolenic acid 2.0% max; 20:1 eicosenoic 5.0 to 17.0%; 20:5 Eicosapentensäure 7.0 to 16.0%, 22:1 erucic max 1.5%
